Public Briefing Sessions on the Draft of Second Basic Plan of Inzai

The Mayor Will Explain the Plan Directly to Residents

Inzai City formulated the Comprehensive Plan (Fiscal years 2021-2030) in 2021 (Reiwa 3), setting a future vision for the city and promoting community development. As the period for the First Basic Plan, which forms part of this Comprehensive Plan, is coming to an end, we are currently working on formulating the Second Basic Plan, which will begin in fiscal year 2026.

We have now finalized a draft plan and will hold public briefing sessions. We look forward to your participation.

Recruiting Participants for Agricultural Training

The city operates an Agricultural Job Service that connects job seekers interested in working on farms with farmers needing labor.

Job seekers must participate in the agricultural training listed below to learn basic farming knowledge.

After registration, you will need to find your own employment based on the job postings. Conditions (wages, working hours, etc.) will also be decided through direct discussion between both parties.

*Includes a 1-hour lunch break (2 times total)

Content: Practical training in agricultural work (field cultivation) at farms within the city
